The transition of your TD Ameritrade Institutional account to Schwab Advisor Services is on track to be completed by Tuesday, September 5, 2023.

To help make sure you have a smooth experience, we're sending this letter and the accompanying guide with key points to know, important dates, and action steps for you to take as part of the transition.

## What isn't changing: Your advisor's relationship with you.

When you and your investment advisor work with Schwab, you'll have access to a wider array of products and services, but one thing won't change: Your advisor will remain just as committed to your relationship and providing guidance built on a foundation of trust.

What is changing: You'll have a ne	w account number at Schwab.

Be advised, if you recently changed the tax ID number on your account or made certain changes to the account registration, that may trigger the issuance of a new account number. If that occurs, you will receive another letter with a new eight-digit Schwab account number to replace the account number shown here.

## When is the transition happening?

At 8:30 p.m. ET on Friday, September 1, 2023, we'll begin moving your TD Ameritrade Institutional account to Schwab Advisor Services. You won't have access to your account as we transfer your assets and account holdings over the course of the weekend. We regret any inconvenience this may cause, but rest assured, beginning on Tuesday, September 5, 2023, you will have the ability to access your account through Schwab Alliance (see the following section).

# What to know now

- Your relationship with your advisor will remain the same.
- Your account holdings will automatically transfer to Schwab.

### Accessing your new Schwab Alliance account.

Beginning Tuesday, September 5, 2023, you'll access your account through Schwab Alliance (schwaballiance.com), our customized website and mobile platform that allows you to work easily and securely with your independent investment advisor and Schwab.

If you haven't already done so, please make sure you set up Schwab Alliance credentials as soon as possible. This will ensure you can view your accounts and approve any transactions initiated by your advisor.

- If you have a Schwab Login ID and password, there's nothing you need to do. You can log in with these credentials.
- Need to set up your Schwab Login ID and password? Go to Schwab Alliance (schwaballiance.com) and select New Schwab user, then follow the prompts. If you'd like to use your existing TD Ameritrade Institutional Advisor Client login as your Schwab Login ID, enter that information after clicking New Schwab user.

At Schwab, login info is tied to an individual person. Each Schwab client has their own unique Login ID and password, which automatically groups accounts with the same owner together, and they can be accessed under one login ID. After your account transitions, you will be able to access accounts managed by your advisor and accounts you manage on your own or with other third parties all in one place. You can also customize your settings and approve transactions initiated by your advisor using eAuthorization.

Please note: Each person associated with this account must have their own Schwab Login ID and password. You will only need to set up one set of credentials, one time.
